Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. How?	All financial companies need to share a customer’s personal information to run their everyday business - to process transactions, maintain customer accounts, and report to credit bureaus. What we do

How does The Ultimus Group, LLC protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does The Ultimus Group, LLC collect my personal information?

We collect your personal information, for example, when you

- Open an account
- Give us your income information
- Provide employment information
- Provide account information
- Give us your contact information
- Visit our website

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

**Nonaffiliates**

A formal agreement between nonaffiliated financial companies that together market financial products and services to you.

- *Our joint marketing partners include other financial service companies.*

**Other important information**

**California:** Under California law, we will not share information we collect about you with companies outside of The Ultimus Group, LLC, unless the law allows. For example, we may share information with your consent, to service your accounts. We will limit sharing among our companies to the extent required by California law.
